

DALWOOD PARISH COUNCILMINUTES OF THE MEETING OF DALWOOD PARISH COUNCIL HELD ONWEDNESDAY, 1ST MARCH 2017AT 7.30 p.m. IN DALWOOD VILLAGE HALL

1. PRESENT : Cllr. K.G. Laing (Chairman), Cllr. P.H. Lawrence (Vice-chairman), Cllr. A.P. Benger, Cllr. G.J. Perry
Cllr. L.P. White, the Clerk and Dist. Cllr. I. Chubb and 1 member of the public.

2. APOLOGIES : Cllr. G.R. Cooper (absence approved on health grounds), Cllr. K.J. Gigg and Cty. Cllr. Moulding.

3. MINUTES OF THE MEETINGS HELD ON WEDNESDAY 21ST SEPTEMBER AND 4TH NOVEMBER 2016: these were not available on account of the Clerk's indisposition.

CLLR. LAING PROPOSED THAT AGENDA ITEM 10 BE BROUGHT FORWARD FOR THE CONVENIENCE OF THE HON. FOOTPATH WARDEN.

4. PARISH PATHS PARTNERSHIP REPORT: Mr. Morgan reported that both vegetation cuts had taken place. The hand rail by the steps on F.P. 15 had been replaced. A temporary 12 foot gate had been installed on Bridle Way 2 following damage by a contractor but some further work would be needed on the catch and a permanent gate and post will be installed and the finger post will be replaced at the contractor's expense. Mr. Morgan said that the Annual Surveys were under way and thanked those who had volunteered to help with these. He said that Devon County Council was applying for a capital grant to undertake works on this path.

Mr. Morgan left the meeting at this point.

5. POLICE REPORT: no crime had been reported.

Referring to progress of expenditure against budget, the Clerk said that the only area of concern was Sundries, which was £1807 in excess of budget because of the decision to purchase commemorative medals to mark the

90th Birthday of H.M. The Queen and because of the purchase of a replacement defibrillator as the existing one had reached the end of its lifespan. It is likely that the Parish Council will be re-imbursed for the bulk of this cost.

b) Requests for Financial Assistance - Cllr. Lawrence, seconded by Cllr. Benger, proposed that £75 each be donated to Axe Valley and West Dorset Ring and Ride Ltd. and East Devon Citizens' Advice Bureau. Agreed.

9. NEIGHBOURHOOD PLAN: Dr. Fearnley had requested a copy of previous minutes relating to Section 106 Moneys and some background information.

10. HIGHWAY MATTERS:

- a. Response to Matters Reported Previously – work at Moorcox Lane was now completed.
- b. Matters to Report: Sunnylands Lane remains in a very bad condition. There are potholes at White Lodge, on Holmes Knapp, near Tuckers Den and Herons Mead on Dalwood Lane, by Cobb Cottage, 4, Danes Hill, Lea Farm and Combeshead Lane. The Clerk will report these on the system and to the Neighbourhood Highway Officer.

A resident had informed the Clerk that the parapet of Millwater Bridge had been damaged.

The Community Road Warden Scheme will be put on the next agenda.

11. MATTERS OF URGENCY: None.

12. EMERGENCY PLANNING: Cllr. Lawrence proposed that a bag of sand be ordered. Cllr. Perry seconded the proposal. Agreed. Concerns were expressed that the river was cutting back by Waterfall Cottage. Contact will be made with a representative of the Environment Agency to discuss this matter.

The Clerk said that some resilience money may be available. Flood warning signs, barriers and cones were considered the best equipment to purchase.

13. MAINTENANCE MATTERS:

- a. Notice Boards – the Clerk had spoken to the contractor but he had not yet made a site visit.
- b. Grass Maintenance – Mr. Morgan had stated that the contractor would undertake the work on the same basis as in the past year.
- c. Telephone Kiosk – nothing to report but it was observed that the letter boxes had not been painted for some time. The Clerk will draw this to the attention of Royal Mail.
- d. Bus Shelters – these were in sound condition.
- e. Tree Matters – dead branches which stick out can be lopped.
- f. Seats – nothing to report.
- g. River Gravel – nothing further to report.
